



## BARKANTINE ESTATE January 2020

The newsletter of the 4 Estates Forum, a group of residents, independent of One Housing

### Consultation continues in the 3 areas across the Island, where residents are involved in making a decision on the future of their homes

The consultation in the three distinct areas across the Island where residents will be making the decision on the future of their homes will continue during 2020.

Each of the areas will be undertaking the consultation at their own pace, with the residents of Kedge House, Starboard Way and Winch House likely to make their decision this summer.

Residents have a range of options; from doing nothing, refurbishing the blocks, extending the blocks, or knocking some, or all of the blocks down and replacing them with new homes.

After extensive consultation, the decision will be made by residents through a ballot. The rules to the ballot are set out by the Greater London Authority (GLA). Under these rules the decision will be made by the tenants, resident leaseholders and housing applicants who have been on the Council's housing list for at least a year.

So, what is the latest in the three areas? Each of the areas has a Resident Steering Group which meet monthly, and they all have a different approach to each other. The Residents Steering Group for **Oak House and Alice Shepherd House** in Manchester Road, on the **St Johns Estate** have appointed PRP as the architects to work with them on developing options for their blocks.

At the end of January 2020 there will be two drop in sessions to meet the architects and to identify what they like and don't like about their homes and



blocks. This information, along with the results of the survey undertaken by 79% of the residents earlier on in the year, will be used by the architects to work up some initial options for residents to consider at a further drop in session.

The Resident Steering Group at **Kedge House, Winch House and Starboard Way** in Tiller Road, on the **Barkantine Estate** are very keen to finalise the options for their blocks as soon as possible.

They have also appointed PRP as their architects and have already had four drop in sessions (one of which is pictured above) for residents to meet the architects and comment on the first draft of the options that the architects have proposed. The comments from the last session will result in amended options to be considered at further drop in sessions to be held in February 2020.

At their January 2020 meeting, the Kingsbridge Estate Resident Steering Group received an interim report on the joint survey that is being undertaken by New Mill and One Housing to find out from residents what they like and dislike about their current home.

The surveys will be completed by February and a full report will be considered at that month's meeting. The February meeting will also discuss appointing architects.

Over the coming year, where a group has appointed architects, they will be making sure that the options that are being developed involve as many residents as possible in the consultation, through surveys, drop-in sessions, one to one interviews etc.
