News from your Residents Steering Group



As we told you in our January newsletter, the Resident Steering Group for Alice Shepherd House and Oak House have started to meet with One Housing Group. The Committee Members from the Tenants & Residents Association (TRA) are also attending as observers to give their support to the Resident Steering Group.


Over the last three months the Resident Steering Group have had confirmation from One Housing Group that:

- No decision has been made about the future of Alice Shepherd House and Oak House.
- Residents will decide on the future of the blocks through a formal independent ballot
- Residents will develop the options for the future of the blocks
- The options will range from doing nothing, refurbishing the blocks or demolishing the blocks and replacing them with new homes.

At the last meeting with One Housing Group, the Resident Steering Group asked for confirmation that Alice Shepherd House is structurally sound, so that residents don't waste time working up proposals to refurbish the block. Hunters' who carried out the stock condition survey' advised that it is structurally sound. Residents then asked for One Housing Group to provide similar information for Oak House.
